



# THE FACTS ABOUT FAMILY SUPPORT

**WEAKLEY  
COUNTY**

Begun by the Division of Mental Retardation Services (now the Department of Intellectual and Developmental Disabilities) in 1988, the Family Support program was formally established by the General Assembly in 1992. Family Support is a flexible, family-friendly program that supports Tennesseans with all types of severe disabilities to live in their own homes and communities. Family Support is a very cost-effective program that prevents many people from needing more expensive programs.

## THE PEOPLE

- Family Support served 4,523 individuals statewide in FY 10-11
- Maximum allowable per person is \$4,000 in direct aid each year. **The statewide average in direct aid per person was \$1,387 in FY 10-11**
- 3,455 families were on the statewide waiting list at the end of FY 09-10
- **16 families were served in WEAKLEY County in FY 10-11**
- **Average of \$2324.44 direct aid per family in WEAKLEY County**
- **0 families were on the waiting list in WEAKLEY County at the end of FY 10**

## THE FUNDING

- Statewide funding reached its highest level (\$7,679,400) in FY 05 and remained at that level until January 2009, when funding was reduced to \$6,665,237. In FY 2010 it was reduced to \$6,364,237.
- Prior to FY 10, funding came from state general appropriations. However, all but \$200,000 of funding for FY 10 came from economic stimulus recovery funds.
- Funding for FY 2012 was established at \$7,383,600 with all but \$200,000 coming from the state's Rainy Day fund, at which point it was recognized as the only program available to individuals with certain forms of developmental disabilities.

## THE PROVIDERS

Family Support Services are provided in all 95 counties by private nonprofit agencies. The agencies are guided by local volunteer councils. Agencies receive a small state funding allocation to staff and operate the program. Communities often supplement state dollars with local in-kind services and supports to families.

## A COST-EFFECTIVE SOLUTION

## COST COMPARISON ACROSS PROGRAMS (DATA COMPILED IN 2010 OR MOST RECENT AVAILABLE)

Family Support is the least expensive of all programs that provide home and community-based services to people with any type of developmental disability. The total (direct costs plus program operations) average annual cost in FY 2010-11 for each person served was only \$1,632.
